033/25 Apologies	All Councillors present. District County Councillor Roger Jackson and District Councillor Tim Wendells sends their apologies.

035/25 Minutes of previous meetings	Minutes from July's meeting have been agreed as correct when circulated electronically, however these were unavailable for signing and will be presented at September's meeting.
036/25 Opportunity for questions from members of the public	N/A – no members of the public present
037/25 Community Matters	Christmas Tree electricity supply quote (MT and TD) Full council resolved to pay for the works quoted by Via which was a higher cost than originally anticipated. TD to send purchase order and supporting documents provided by Cllr MT.
038/25 Planning	Applications: i) Bulcote Farm Development - 25/01224/S19LBC Application for variation of Condition 2 of PP 15/00785/LBC – response required by 20/8/25 Full council resolved to object to application – material reasons: loss of amenity space and added resident density, therefore more traffic and parking concerns. This objection is to be supported by a letter from our Chairman. Additional issues discussed: Residents are reporting the traffic system specified in the Construction Method Statement 'one way in, one way out' is not being adhered to and even when this is, the size of vehicles are very large causing concerns of damage to their properties. Residents are reporting work is beginning on site earlier than 8am as on the plans. There have been multiple early starts from 7am. Residents are also reporting trees overgrowing on the land boundary with the road/bridleway – could this be cut?
